Lorean Gibson of Lumos Networks has submitted a project to install fiber optic cable. This project will will start at a Verizon Pole 1635P at the intersection of Old Graves Mill Rd and Pearson Drive. They will riser down from the pole and then make a buried crossing of Old Graves Mill Rd to the south side of Pearson Drive; then make a buried crossing of Pearson Drive to its north side, from there continued buried along Pearson and then Beverly Hills Circle unit it gets to 311 Beverly Hills Drive which is the private entrance for Timberlake Ruritan Club and Recreation area. From there the project will be buried across private property where it enters 315 Beverly Hills Circle and continues to a cell tower on that site. (There is no review fee for this project.)

Then SEGRA will riser down bore across Rivermont Avenue to Toler Street and Early Street where it will go onto Centenary Methodist Church at 1501 Rivermont from the Early Street side.
